



CALL FOR ARTISTS REF. AAE#1902 "ARTINGOUT ART EXHIBITION 2020-2021" *12 MONTHS OF EXHIBITION EVENT FOR 24 SELECTED ARTISTS*

1. PRESENTATION

ARTINGOUT, in the occasion of the opening of its first "showroom" in the historic center of the art city of Pavia, realizes a unique and exclusive exhibition event, dedicated to 24 carefully selected artists. An exhibition that will cover a period of 12 months in a location that is always active and full of events and cultural initiatives. ARTINGOUT is a reality of artistic promotion that boasts citations in books and university level theses, used by different artists as a reference for the listing of their works, quoted on the Mondadori Catalog of Modern Art (CAM) and on the Catalog of Modern Art. Contemporary ACCA Edizioni. It has been featured in various issues of the monthly ARTE Mondadori and in the ARTEARTE magazine as well as published in prestigious monographic catalogs. After ten years of experience dedicated to the promotion of visual arts through online media, the opening of the first showroom marks a new phase of the project. The physical presence on the territory, the creation of concrete and accessible space that can represent an opportunity for growth and visibility for the exhibited artists, allowing the encounter between one's own creative production and the world of art collecting.

3. ADMISSION REQUIREMENTS AT THE SELECTION PHASE

- the selection phase is open to all artists working in the field of visual arts;
- the following types of works of art are eligible for selection: painting, pictorial sculpture and material, photography, graphics, design, illustration, and sculpture (details in point 4);
- a maximum of 24 artists will be selected by the editorial staff - the editorial judgment is final and unquestionable;
- participation in the selection phase is subject to the payment of a fee of € 50.00 (including VAT) for management and secretarial expenses (a 20% discount is available for owner of valid Artingout Card).

4. CHARACTERISTICS OF THE ARTWORKS

ADMITTED WALL ART WORKSHOP

The wall art works must have a maximum size, including any funds or frames, 120cm high and 70cm wide. Works of painting, art, photography, graphics, drawing, and illustration are allowed.

SCULPTURE

The sculptures must be excluded from the ground with a maximum overall dimensions of 60cm high x 40cm wide x 40cm deep (excluding support base).

5. SELECTION AND MEMBERSHIP FEES (all costs shown include VAT)

Participation in the "ARTINGOUT ART EXHIBITION 2020-2021" includes an access fee for the selection of € 50.00 (fifty / 00) against secretarial expenses (non-refundable but deductible, for the selected, from the final membership fee) and a cost of participation in the exhibition event (including all the services indicated in point 3) of only € 50.00 per month for an annual total of € 600.00 (six hundred / 00) less the access fee for the selection already paid. - the selected artists will receive further information about the terms of confirmation of the adhesion;
- artingout reserves the right to extend the call in case of places still available.
- all candidate artists will receive a personalized gift signed by Artingout.
